The Annual Conference of 2019 in Como, 14-15 March, has been a big success. Almost 90 people from 14 countries of our CHAIN5 community joined us in Italy and enjoyed the warm hospitality of Cometa and IATH.

On Wednesday the 13th, 55 of them participated in the social programme, learning more about the role of the Higher Vocational Institutes in Italy, and getting an inside view of ComoNext, an innovation centre, being very important for the region.

On Thursday and Friday the programme has been very interactive, having a lot of workshops and sessions, combined with inspiring key-notes about specific issues. Based on this we are able to go on with a number of interesting themes for our community of practice...

Next Annual Conference

With the general agreement of those present in Como, it was decided to accept the offer from the Tallinn School of Economics to organize the next annual conference in its hometown in Estonia. The conference itself takes place on Thursday 12 and Friday 13 March 2020 on the campus of the Tallinn School of Economics (TMK - http://www.tmk.edu.ee/?id_lang=2).

As you are used to from us as CHAIN5, the conference is preceded by a 'social program'. For this, TMK will examine which activities provide insight into the role that the School plays in the region, together with other partners and organisations.

After the summer holidays we will provide further information about the Annual Conference. It also will indicate how the working groups set up in Como provide workshops in Tallinn for a number of themes. But then there will be also messages about how a contribution can be made in other ways, in line with our working method as a community of practice.

So at least keep the dates in your diary. And make sure that this week is included in your planning in such a way that you and all other colleagues can continue to work on practical issues related to 'the level 5 area'.

But there were also 12 workshops on all kinds of themes that will be elaborated for CHAIN5 in the coming years by thematic working groups (see below). It is certainly interesting to take note of what was discussed in the workshops.

Conference in Malta

There will be a conference in Malta on 9-10 December 2019 (starting on the 8th in the evening) on the connection between the overall system for more vocational and professional oriented education at the higher levels of the EQF – like Higher VET - and the European Higher Education Area (EHEA). This can be relevant for national systems, to discuss progression routes and permeability between these sectors.

The conference will be organized by EfVET (www.efvet.org) and CHAIN5, and hosted by MCAST in Malta. The Ministry for Education and Employability will also be involved.

EAN – European Access Network

During the annual conference of the EAN one of the topics that will be discussed, is the role of level 5 for having better opportunities for students (youngsters, adult learners, workers), getting a formal diploma in higher education. Aspects of this topic that can be highlighted are: permeability between the levels 4, 5 and 6, national policy concerning level 5, role of HEIs, dual learning, and the need for more attention for offering level 5 qualifications for specific target groups.

EAN 2019 annual conference: Drivers for change: policy and practice
28-30 October 2019 - Ghent – Belgium

The EAN 2019 Annual Conference encourages better policy making and improves best practices through the sharing of ideas and knowledge and by connecting policy makers, researchers, experts and practitioners. The general theme of this year, Drivers for change: policy and practices, consists of three tracks:

1. Foundations for policy
In this track, EAN 2019 collects examples of policies and building blocks for policy makers. Things that come to mind are institutional or national framework, policy supportive materials and research on shaping and moulding your organizational structure and culture.
2. Inspiring practices for the future
EAN 2019 offers a floor to good examples from the field. Based on the topic, the conference will group presentations.
3. Policy in practice
Together with other professionals, look at the interaction between practice and policy. What came first in your institution? How was policy shaped or what good practice was based on policy?
Presenters are invited to discuss both during their presentation, preferably with attention on how they interact.

“EfVET President attended the 6th Annual Conference of Chain 5 on “Making the European level 5 area a reality”, which was held at the premises of Cometa Formazione in Como Italy. EfVET President Joachim James Calleja closed the conference by stressing the importance of join forces to support European VET and ensure that the sector receives adequate resourcing at European and national levels.

Chaired by **Hans Daale**, President of **Chain5**, the conference focused on *Making the European 5 Area a Reality*. A number of workshop sessions fed into two plenary sessions in which over ninety participants could exchange views on the future of the Level 5 qualification. Hans Daale opened the conference with a presentation on the future of the European Level 5 Area and the role of CHAIN5.

Alex Keys from QQI Ireland spoke about quality assurance of qualifications in relation to the world of work while the President of the Istituti Tecnici Superiori (ITS) of Italy and General Manager of

COMETA, EfVET Member, Alessandro Mele delivered an overview of the support ITS give to VET students across the Italian territory and in particular the importance of work-based learning in industry.



Kinga Szebeni from DG Employment, Social Affairs and Inclusion of the European Commission spoke about the Level 5 qualification from a European perspective and in particular from studies and initiatives were undertaken by the European Commission over the past years.

In his closing speech, the **President of EfVET** spoke about the need to synergize the capacity that both CHAIN5 and EfVET members have with regards to their hands-on experience in vocational education and training. Practitioners and training providers are in pole position to influence VET policy not only at regional and national levels but also at the European level.

“Talking about VET and doing VET is not the same”, **Professor Calleja** reiterated. The first is much easier to express than the second.

“An excellent example of factual VET is the Association COMETA where principles of work-based learning are put into practice on a day-to-day basis...where empathy and support are embedded in all learning relationships... the time is ripe to empower practitioners and training providers to join forces and speak loudly about the need to raise the political and institutional profile of VET across Europe... time is moving fast and lost generations will never be recovered again unless we empower young generations with collective values and the skills and competences needed to live independently” the President of EfVET said.



Vocational qualifications today are in greater demand than in the past. These range from the lower levels of qualifications frameworks to higher education and the momentum to increase higher VET is clear evidence that the labour market in many countries is valuing VET qualifications much more than before.

For this purpose, EfVET President invited CHAIN5 participants to take part in a conference which will be held in Malta on 9-10 December 2019 jointly organised by CHAIN5, EfVET, the Maltese Ministry of Education and Employment and MCAST on Level 5 qualifications as agents of change in VET and the Labour Market.

Similarly, he invited CHAIN5 participants to join EfVET members at the Annual EfVET Conference in Portugal on 22-25 October to discuss *Robots, Human Capital and Digital Learning – Managing Transition and inclusion*. The two events will bring together a very blend of practitioners and training providers to forge “a more realistic roadmap that European VET should take to ensure that learners acquire qualifications which are relevant to today’s and tomorrow’s labour market... VET reform systems should pick up speed and respond to technological changes in a more forceful and focused manner than today” Professor Calleja concluded.”
