

Reforming the education system for vocational education on tertiary level

2013	The government points out a commission to write a green paper on vocational education (tertiary level)
2014	The green paper is published
2016/17	A white paper is published and approved in the Parliament
2018	New law on Higher Vocational Education passed by Parliament
2019	New regulations into place



Key elements of the reform

- Enhancing quality development
- Structure level(s), length, credits and degrees



MAJOR CHANGES



- New law passed in Parliament June 2018
- Upgraded to Higher Vocational Education
- Exemption option studies up to three years
- Degrees approved by the Ministry of Education in
 - Professional degree (one year)
 - Higher professional degree (two years)
- Same credit system as universities and university colleges
 - National OK
 - ECTS/International: Need to revise according to Standards and Guidelines for Quality Assurance in the EHEA
- Revision of the National Qualification Framework

National Qualifications Framework

Established in December 2011

Planned revision by Ministry of Education within 6 years – now longtime overdue

Indications that some studies are expanding into level 6.

MANDATE

- Inquire if some studies are at level 6?
- Need to establish learning outcomes for Higher Vocational Education at level 6?

FINDINGS OF THE WORKING COMMITTEE

- Several studies breaking into level 6
 - Technical studies where specified certifications are linked to the study programs in the electrical and construction industry
 - Maritime studies based on the international standard for qualifications and certificates for seafarers (STCW Convention)
 - IT, communication and media studies that qualify for further studies into Higher Academic studies in Norway and abroad
 - Fashion studies based on a recognized international fashion education, where three years studying in France qualifies for admission to master's programs in other European countries

RECOMMENDATIONS OF THE WORKING COMMITTEE

- Establish and suggest a new set of learning outcomes for Higher Vocational Education at lever 6 towards the Ministry of Education – for the limited study programs concerned
- In the longer scope look into the possibility of establishing a binary system with parallel sets of learning outcomes for an academic and vocational pillar in higher education
