


THE NORWEGIAN COUNCIL FOR HIGHER VOCATIONAL EDUCATION

- Representatives from private and public Higher Vocational Colleges, Business and Employer Associations, Trade Unions and Students






DEVELOPMENT OF THE REFORM THE LAST YEAR

- Intermediate reports of status halfway in the five-year reform – produced by the government
 - Status on the 48 measures
 - Evaluation of the financing system
- Government working on a strategy for the coming years
- National Council report on further development
 - Plan for escalating the number of students
 - Model for financing of colleges and quality development
 - Model for meeting the needs in the workplace
 - Development of NQF to possible binary system with Higher
 Vocational Education on EQF level 5-7(8)
- New law this spring will open for Higher Vocational Education in the span from 1 to 120 credits




REFORM OF LIFELONG LEARNING

- Passed in Parliament spring of 2020
- Emphasizes Higher Vocational Education
 - 10 different industry programs the social partners define the needed skills in small credit courses public funding
 - Flexible educational programs with focus on digital skills public funding
- Target groups: Unemployed, laid off and those in need of upskilling
- The State Loan Fund now also for employed adults seeking upskilling and reskilling




CRISIS MEASURES TOWARDS THE PANDEMIC

- Extra 100 million euro in 2020 plus extra 100 million in 2021 towards up-skilling of unemployed and laid off
- Major parts of this directed towards Higher Vocational Education
 - 10 different industry programs the social partners define the needed skills in small credit courses
 - Flexible educational programs with focus on digital skills
- 25% increase in students in regular studies of Higher Vocational Education from 2019 to 2020




TIMEFRAME TO DEVELOP AN EDUCATIONAL REFORM

- 2013: The government set down a commission to write a green paper vocational education on a tertiary level
- 2014: The green paper is published
- 2016/17: The white paper is published and approved in the Parliament
- 2018: New law on Higher Vocational Education
- 2019: New regulations
- 2020: Reform of Lifelong Learning
- 2021: Revised law on Higher Vocational Education



HOW DID WE GET THERE?

- Established a broad alliance
 - Privat and public Higher Vocational Colleges
 - Students
 - Social partners
- National Council for Higher Vocational Education
- Pro active work towards the Parliament, Ministry of Education and relevant Directorates
 - Working committees write reports
 - Meetings with decision makers on a bureaucratic and political level – presenting issues and suggested solutions
