
("New") Credit System

- Croatian Qualification Framework Act (2021)
 - HROO (Croatian Credit System for General Education)
 - 15 25 hours = 1 HROO
 - CSVET (Croatian credit system for VET) → NEW (2/2021)
 - 15 to 25 hours = 1 CSVET
 - CSVET = ECVET
 - ECTS
 - 25 30hours = 1 ECTS

- Learning outcomes descriptors
 - 8 levels of descriptors → state the minimum requirements for linking a unit of learning outcomes to the appropriate CROQF level
 - Level 5 only level that does not use its own level of descriptors!

Minimum 60 CSVET or 120 ECTS points, of which are at least 30 CSVET or 60 ECTS points on **level 6 or higher level** of learning outcomes.



Croatian Qualification Framework Act

Level 5 = less than 180 ECTS or CSVET points:

- 1. Short cycle professional undergraduate study
- 2. Vocational specialisation programs
- 3. Master craftsman exams

SCHEME OF HIGHER EDUCATION SYSTEM IN CROATIA



Short cycle professional undergraduate study

- Agency for Science and Higher Education
- ECTS
- Standards and guidelines for quality assurance in the European Higher Education Area
- all higher education institutions are subject to regular evaluations through re-accreditation and audit
 - Initial Accreditation of Study Programmes
 - Initial accreditation of Higher Education Institutions
 - Re-Accreditation of Higher Education Institutions

Vocational specialization programs

- Agency for VET and Adult Education
- partial qualifications minimum 10 CSVET points of which 50% are on the level 5
 - minimum duration of 150 hours for renewal and supplement of acquired knowledge and skills and the acquisition of new knowledge in the profession of the same level of complexity
 - minimum 500 hours for vocational specialization a higher degree of complexity

Master craftsman exams

- Croatian Chamber of Crafts and Trades
- 1 year in master craftsman school (future)
- No credit points
- Recognition of prior knowledge both formal and informal
 - work experience is proven by public documents and the employment contract, appropriate certificates, recommendations and statements of witnesses about work on certain jobs.
 - official program with defined topics of theoretical and practical examination
