Introduction

Hereby the first newsletter for the Annual Conference (AC) in Oslo, Norway, to be held from 9 to 11 March 2022. We give you the first information about the program and some of the organizational matters related to it.

We assume the possibility of being able to physically hold a conference again. Certain parts of the program will certainly be streamed. We also keep the option open to provide a number of sessions online, in parallel with the physical sessions. This will be discussed this in the following newsletters, together with what this means for the registration.

You are more than welcome...

Of course we look forward to meet as many members of CHAIN5 as possible during the Annual Conference, the opportunity to meet each other as teachers, coordinators, counsellors, program managers, program directors, quality assurance experts, staff members, national coordinators, experts in the international context, and everyone who has found a place within the community. But it is also the opportunity to get acquainted with CHAIN5, the theme groups and other networks, and to learn about current developments around 'level 5', nationally and internationally.

The theme...

The theme of the AC relates to the way in which the provision of qualifications at level 5 can be designed and the role that the stakeholders play in this in consultation with the institutes that take care for the 'shape' of education. Stakeholders mean the organizations that can, may and want to involved in those qualifications in one way or another.

We are going to look at this from the national context, so what could be going on around the stakeholders at that level. Based on this, our community can look at two sides, namely the way in which regional and local cooperation can be achieved, but also how internationally we can learn from each other, about how to deal with the stakeholders and in what way to involve them in the provision of qualifications and programs.

Stakeholders that we can consider include: government (ministries), parliament, employer representatives, accreditation organizations, student associations, educational umbrella organizations, municipalities, social partners, chambers of commerce, national coordination points (NQF...).

In order to be able to deal with the theme in concrete terms, we will look at the situation in Norway, at the way in which in recent years, with the support of all kinds of stakeholders and other organizations at level 5, Higher Vocational Education has been developed. During the conference it will examined what this has brought about on 'the floor' of institutions and their networks. In concrete terms, it will be seen what this means for teachers, coordinators and program designers, i.e. what happens in a practical sense when there is a good and effective collaboration with all kinds of stakeholders.

Tracks during the conference and contributions by members

In addition to the usual elements of the AC, we decided to work on four tracks during the two days when designing the sessions. We create a certain order in the offer so that the participants can draw up their own program, with the focus on a certain track or by continuing your 'shopping'.

The four tracks during the conference are:

- 1. Level 5 in the national context: how about the role of institutes and the national approach
- 2. Theme groups: discussion, plans and opportunities for the near future
- 3. Stakeholders and their roles in offering level 5 by institutions
- 4. CHAIN5 and the community theory and practice related to the European Level 5 Area and the European Education Area, and international collaboration

In the next issue of the newsletters we will explain these tracks further, with several examples. Then you will also receive information about the possibility to make a proposal for contributions from your side, for sessions, looking at those tracks.

Prelimenary programme
