





### The student survey for vocational school students

- Commissioned by the Ministry of Education and Research
- Conducted annually since 2018 (pilot in 2017)
- "Sister"-survey to the student survey for university- and university college students, which has run since 2013
- Population: all vocational school students who had studied for more than one semester, and some vocational school students in their first semester of study
  - 2022: Around 20 000 recipients and over 9000 respondents, accounting for approx. 720 programmes at 57 vocational schools
- Results made public in September each year, at programme level
  - Vocational schools receive results earlier





### **Purpose and use**

- The purpose of the student survey is to give educational institutions, students, higher education applicants, the government and other stakeholders information about educational quality in the vocational education sector
- Results shared with vocational schools in the form of raw data and curated graphical reports
- Datasets also made available to researchers through Sikt (Norwegian Agency for Shared Services in Education and Research)
- Primary practical application today: a resource in vocational schools' quality development work
- At NOKUT: used in various reports and analyses, and as one among several quality indicators in the quality assurance of study programmes

## Evaluation of The Norwegian qualifications framework for lifelong learning (NQF)

- The Norwegian qualifications framework for lifelong learning (NQF) gives a view of the Norwegian educational system and its levels of qualifications. NQF is meant to facilitate the work on lifelong learning, as well as ensure that qualifications are transparent and understandable.
  - Tertiary vocational education currently at level 5 in NQF
  - Universities/university colleges at level 6-8 (BA to PhD-level)
- NOKUT is currently conducting a comprehensive evaluation of NQF, commissioned by the Ministry of Education and Research
  - Examines a) how NQF is currently used, and b) whether NQFs stated goals are currently fulfilled, as well as potential obstacles and future measures
  - Project also looks at the prerequisites for, and possible consequences of, opening up for vocational education at higher levels in NQF
