Ingrid Marie Aarre is the elected president of the organization and works to uphold the students' interests, rights and the conditions of students in HVET in Norway.






Students' Choice of First-Year Upper Secondary Programme in Norway (2024)




Students in Norway by Type of Institution (2024)

- Schools are presently allowed to offer programs at EQF level 5, but will – in the foreseeable future, be able to offer programs at EQF levels 5, 6, and 7.
- Study credits from H-VET will be aligned with ECTS.


